

CONSENT TO THE PROCESSING OF THE PERSONAL DATA

I hereby give consent for SkyCloud s.r.o, with registered office Prague – Nové Město, Revoluční 1403/28, Postal Code 110 00, Company ID No. 04903641 recorded in the Commercial Register administered by the Municipal Court of Prague under file no. 255406 C (hereinafter “**Company**”), to process my personal data as the controller to the extent of first name, last name, telephone number, email, date of birth, address, request and communication history, copy of travel documents, passport, or citizen ID card (hereinafter “**Personal information**”).

I confirm that I have been informed of my rights under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (see “**GDPR Regulation**”), primarily about the fact that I have the right to access my Personal Data, the right to be forgotten, the right to correct inaccurate, incomplete, or obsolete Personal Data, and other rights stipulated by Articles 15 through 22 of the GDPR Regulation, in particular:

- a) the right to request of the Company information on the processing of my Personal Data and the provision of such information without unnecessary delay;
- b) the right to request explanation of the Company, as well as a remedy to any emergent situations, namely via blocking, correcting, supplementing, or deleting Personal Data;
- c) the right to receive information about blocking, correcting, supplementing, or deleting of Personal Data on the part of the Company per item b) above without unnecessary delay, if the providing of such information is possible on the part of the Company or not requiring unreasonable effort;
- d) the right to transfer of data, i.e. the right to receive Personal Data in structured, commonly used, and machine readable format for purposes of transfer to another controller; and
- e) the right to turn to the Office for the Protection of Personal Data in the event that the Company fails to fulfil my request per item b) above.

I consent that my Personal Data may be processed for a period of 3 years. In addition, I consent that my personal data may be processed automatically and manually, in electronic and printed format. Detail
